What's the point?

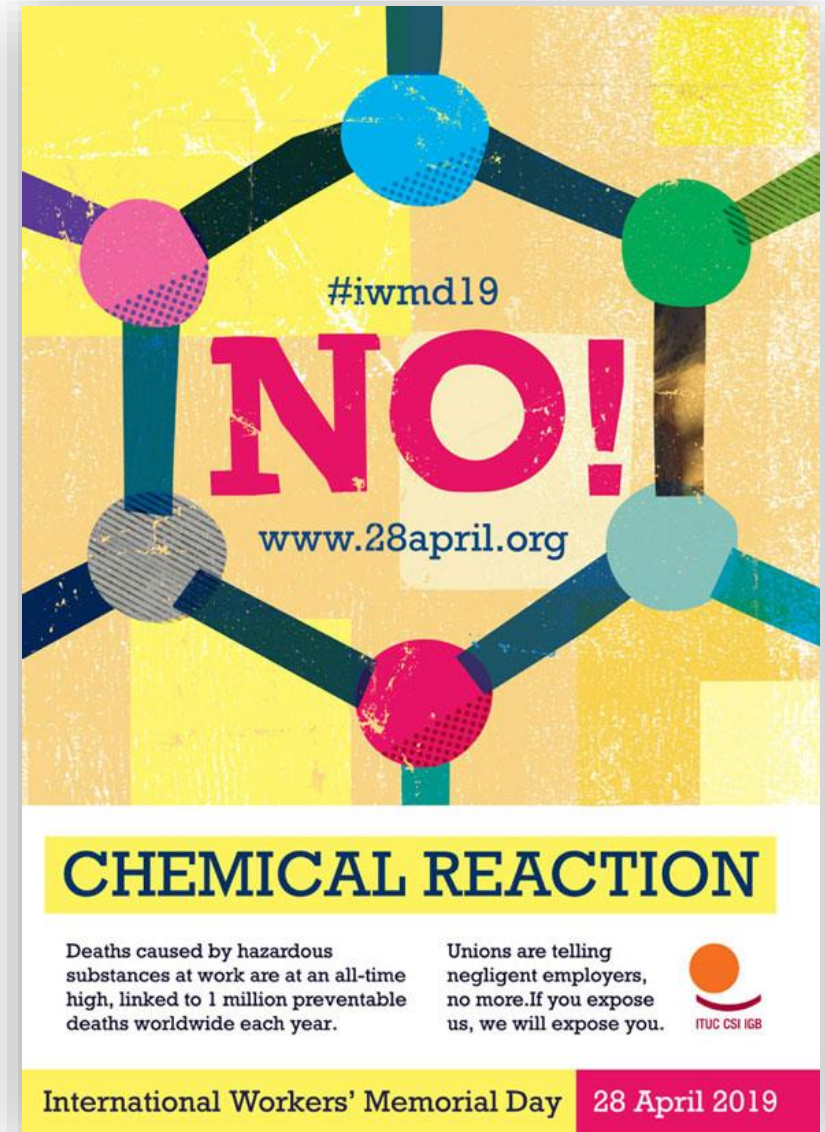
Work-related suicides are not reportable. They are not counted. They are not a workplace prevention priority.
