

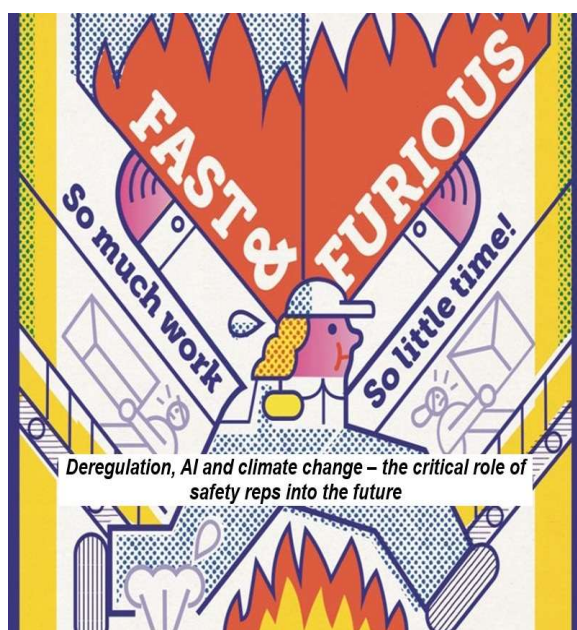

Guest speakers were excellent (New Safety Rep Glasgow)

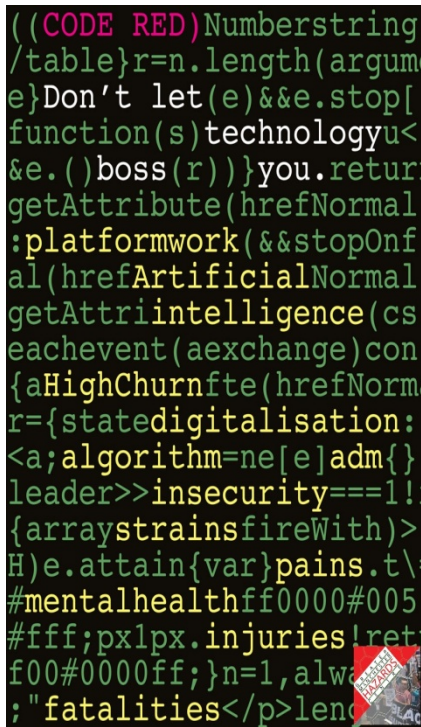
Got ideas on how safety can help engage non union workers (NW Delegate)
